It’s Official: The Trinity River Vision Authority Board Established!



The Trinity River Vision Authority Board meeting in the Tarrant Regional Water District Board Room on January 3rd, 2007.

On October 5th, 2006 the newly formed Trinity River Authority Board held its inaugural board meeting. This was an extremely exciting day for all those that have been involved with the Trinity River Vision Project because it marked the establishment of a new entity with its own budget and decision-making process. The role of the Trinity River Vision Authority Board will be to serve as the governing body for the Trinity River Vision Project and act as liaisons for the participating partners in the project.

The new Trinity River Vision Authority Board consists of representatives from the City of Fort Worth, Tarrant County, the Tarrant Regional Water District, and Streams and Valleys, Inc. The Board consists of Tarrant County Administrator G.K. Maenius, Fort Worth City Manager Charles Boswell, Tarrant Regional Water District President Vic Henderson, Tarrant Regional Water District General Manager Jim Oliver, Streams and

Valleys Board Member and Co-Chair for the original TRV Master Plan Elaine Petrus, and Tarrant County Judge Tom Vandergriff. The Board’s Officers, President Maenius, Vice President Boswell, and Treasurer Petrus were also elected at the October meeting. J.D. Granger was officially appointed as Executive Director for the Trinity River Vision and was also elected as Secretary of the Board.
